### 3. HAZARDS IDENTIFICATION

## 4. FIRST AID MEASURES

---

<b>Inhalation</b>	Move the exposed person to fresh air at once. For breathing difficulties oxygen could be necessary. Get medical attention if any discomfort continues.
<b>Ingestion</b>	DO NOT INDUCE VOMITING! Get medical attention immediately! Promptly get affected personnel to drink large volumes of water to dilute the swallowed chemical. Do not give milk or oil. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.
<b>Skin</b>	Remove contaminated clothing. Wash skin thoroughly with soap and water. Get medical attention if any discomfort continues. INJECTION INJURY WARNING: If product is injected into or under the skin, or into any part of the body, regardless of the appearance of the wound or its size, the individual should be evaluated immediately by a physician as a surgical emergency. Even though initial symptoms from high pressure injection may be minimal or absent, early surgical treatment within the first few hours may significantly reduce the ultimate extent of injury.
<b>Eyes</b>	Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention.

## 5. FIRE FIGHTING MEASURES

<b>Extinguishing media</b>	Water spray, fog or mist. Foam. Carbon dioxide (CO <sub>2</sub> ). Dry chemicals, sand, dolomite etc.
<b>Special firefighting procedures</b>	Use water to keep fire-exposed containers cool and disperse vapours. Water spray could be used to flush spills away from exposures and dilute spills to non-flammable mixtures. Avoid water in straight hose stream; will scatter and spread fire. Keep run-off water out of sewers and water sources. Dike for water control.
<b>Specific hazards</b>	If heated, volume and pressure increases strongly, resulting in explosion of container.
<b>Hazardous combustion products</b>	Acrid smoke/fumes. Oxides of: Carbon. Phosphorus.
<b>Protective measures in the event of fire</b>	Self-contained breathing equipment and chemical resistant clothing recommended.

<b>Personal protection</b>	Minimize skin contact. Avoid breathing vapors; wear appropriate respirator. Remove sources of ignition. Wear suitable eye protection.
<b>Environmental protection</b>	Keep product out of sewers and watercourses by diking or impounding. Advise authorities if product has entered or may enter sewers, watercourses or extensive land areas. Assure conformity with applicable government regulations.
<b>Spill clean-up methods</b>	Ventilate well. Wear necessary protective equipment. Collect spillage in containers, seal securely and deliver for disposal according to local regulations. Do not let washing down water contaminate ponds or waterways. Flush area with water.
